#### LATEST DECISION OF HONORABLE DELHI HIGH COURT

✓AMDHENU ISPAT LIMITED takes this opportunity Shareholders. congratulate its Franchisees, Dealers, Distributors and well-wishers on its considerable success at the preliminary stage in the ongoing legal proceedings initiated against Sh. Pradeep Kumar Agarwal and his Companies namely M/s Kamdhenu Industries Ltd. and M/s Kamdhenu Cement Ltd... It gives us immense pleasure to inform you that the Hon'ble Delhi High Court has been pleased to pass a landmark Order / Judgment on 19.05.2010, which by and large, according to the legal experts, is in favour of KAMDHENU ISPAT LIMITED.

In regard to STEEL BARS/SARIAS, the Hon'ble High Court has restrained M/s Kamdhenu Industries Ltd. (of Sh. Pradeep Kumar Agarwal) manufacturing, marketing or advertising steel bars, stainless steel pipes etc. in the trade mark/logo of KAMDHENU or any trade mark/word/mark/ name deceptively similar to the trade mark KAMDHENU. While recognizing trade mark/trade name/ corporate name "KAMDHENU", the Hon'ble High Court observed that M/s Kamdhenu Industries Ltd. (of Sh. Pradeep Kumar Agarwal) is not entitled to use its Corporate name "Kamdhenu Industries Ltd." or any other Corporate name, in which the mark "KAMDHENU" shall form part in relation to its business of Stainless Steel, Saria and granted M/s Kamdhenu Industries Ltd. (of Sh. Pradeep Kumar Agarwal) time up to 31.03.2011

to adopt/use different name in this regard. As per legal opinion received, with immediate effect. M/s Kamdhenu Industries Ltd.



(of Sh. Pradeep Kumar Agarwal) can not use our corporate name KAMDHENU even by using their company's name M/s Kamdhenu Industries Ltd. In any manner what so ever and even can not use the mark PRIME GOLD with their company's name M/s Kamdhenu Industries Ltd.

& **ALLIFD CEMENT** PRODUCTS, Hon'ble the High court has also restrained M/s Kamdhenu Cement Ltd. (of Sh. Pradeep Kumar Agarwal) from using Logo of Chakra, punchline 'SAMPURNASURAKSHA KI GUARANTEE'. Colour Scheme. Get Up similar to that of M/s Kamdhenu Ispat Limited brand products and while restraining M/s Kamdhenu Ispat Ltd. from using the trade mark / corporate name "KAMDHENU", the Hon'ble High Court conditionally allowed M/s Kamdhenu Cement Ltd. (of Sh. Pradeep Kumar Agarwal) to use the trade mark "KAMDHFNU" in a limited manner, without using our popular Logo of Chakra, Punch Line "SAMPURNA SURAKSHA KI GUARANTEE". Colour Scheme. Get Up with respect to "Cement and allied products" (on interim basis during pendency of suit before the Hon'ble Delhi High Court) that too only when, M/s Kamdhenu Cement Ltd. (of Sh. Pradeep Kumar Agarwal) will deposit a sum of Rs. 1.40 Crores with the Registrar General of the Hon'ble High Court.

As you are clearly aware that currently, we have been dealing with "KAMDHENU SUPER CEMENT" and not "KAMDHENU CEMENT" therefore, we intend to approach the Division Bench of the Hon'ble Delhi High Court to get this portion clarified and to dispel any doubts in the minds of our esteemed Shareholders, Franchisees, Dealers, Distributors and well-wishers.

Besides afore-said, the Hon'ble High Court, while holding Sh. Pradeep Kumar Agarwal guilty for committing the contempt of its earlier order, imposed a punitive costs of Rs. 2 lacs and issued a final warning upon Sh. Pradeep Kumar Agarwal to stay away from violating its orders / directions, in future.
