LIKELY TO HIT KHARIF CROPS YIELD

'Below normal' rainfall in August, predicts IMD

'Moderate' El Nino conditions can impact monsoon

SANDIP DAS New Delhi, July 31

AFTER AN 'EXCESS' rainfall of 13% above the benchmark in July, a crucial month for kharif crops sowing, India Meteorological Department (IMD) on Monday predicted 'below normal' rainfall at 92% of the long-period average (LPA) for the next month which may hit crops yield.

However the met department's forecast predicted 'normal'rainfall in the second part of the monsoon months (August-September) between 94-106% of LPA although 'with a probability on the negative side of the normal benchmark'. Mrutyunjay Mohapatra, director general, IMD said rice growing states in eastern India could receive surplus rainfall in August, while precipitation in rice, cotton and sugar cane growing southern states could be below normal. Rains during August-September which has a share of around 40% in total monsoon precipitation is crucial for the vegetative growth of kharif crops – paddy, pulses,


oilseeds, cotton and sugarcane.

Nino conditions on the monsoon so far, Mohapatra said there is an increasing chance of 'moderate' El Nino conditions adversely impacting the monsoon in the next two months. "At present neutral Indian Ocean Dipole (IOD), which helps monsoon, is likely to develop into positive IOD in

the next two thus negating the impact of El Nino conditions to an extent," he said.

The met department in its forecast has said 'normal to above normal' rainfall is expected over most parts of divisions adjacent to the Himalayas, east central Indian and parts of east and northeast

India while below normal rainfall is likely over southern India, northwest and central India next month.

In the first two months of monsoon months the overall rainfall has been at 'above normal'range of 5% above LPA till Monday. The surplus rainfall of 13% in July had wiped 9% deficiency in rain for June.

With the exception of east and north-east regions where overall rainfall has been hugely deficient at 25% of LPA, other regions north-west (31%), central India (12%) and southern peninsula (5%) have received above normal to surplus rainfall in June-July.

So far 66% of the 717 districts in the country have so far received normal or excess rainfall. Rest of the 263 districts have received deficient and scanty rainfall. No change has, however, been made to the IMD's May 26 forecast that the precipitation this monsoon season (June-September) will be in the "normal" range, at 96% of the LPA. Skymet had earlier said monsoon precipitation this year could be "below normal" at 94% of the LPA.

IMD classifies 'normal' rainfall between 96% and 104% of LPA. Rainfall between 90%-95% is considered 'below normal' and precipitation below 90% of LPA is termed'deficient'.

A SPECIAL SESSION of the Goods and Services Tax (GST) Council should be convened to discuss measures needed to check rising fraud as well as to simplify regulations for small and medium enterprises (MSMEs), said Amit Mitra, West Bengal chief minister's principal chief advisor, in a letter to Union finance minister Nirmala Sitharaman.

"We have been helplessly watching massive fraud taking place in this porous GST system," Mitra said, citing the Centre's information to parliament that ₹1.15 trillion fraud has been detected from GST invoices between 2018-19 to 2022-23. He said it was also shocking that out of 69,426 GST identification numbers verified in the past two months, 20,893 were found to be simply non-existent with GST evasion detected to the tune of ₹19,638 crore. "May I point out that out of the 14 million businesses registered with

GST, only 0.42% of registered tax payers were verified, which yielded the shocking 30% nonexistent and fraudulent registrations. Imagine if all of the 14 million businesses registered with GST were to be verified what unimaginable fraud would be detected," he said.

Drawing attention to the complex web of GST that has been thrust upon the MSMEs, Mitra said till date GST authorities have issued 770 notifications, 178 prescribed forms, "Humongous fraud taking 191 circulars, and 75 amend-

ments in the GSTAct while the tax rate was changed in more than 400 items.

"How do you expect that a MSME company would be able to cope with this gargantuan regula-

Though the intent of GST was to bring in the informal sector entrepreneurs into the formal arena through a simple and transparent GST system, the unfortunate fact today is that 90% of the GST is contributed by large taxpayers who can cope with this complex web of regulations, he said. "The saddest of all, instead of turning informal to formal entrepreneurs through GST, there are concerns that those who have registered from the MSME sector are deregistering or considering deregistering since they are unable to cope with the current structure," he added.

'Need to hike coal washery capacity to curb imports'

MANISH GUPTA New Delhi, July 31

COAL SECRETARY AMRIT Lal Meena highlighted the "urgent need"to enhance the capacity of washeries for coking and noncoking coal to cut down on coal imports at a seminar organised by the Indian National Committee of World Mining Congress.

"India can significantly reduce its reliance on coal imports and promote domestic coal beneficiation," Meena said,

according to a Union coal ministry statement on Monday.

The ministry expects to begin exporting coal to neighbouring countries from next year, it added. There is a need for incorporation of latest technologies and opening of new mines to boost coal production efficiently, Meena said.

Numerous railway projects are underway to overcome transportation constraints to support the coal industry's growth, he added.

THE DELHI Police has informed the Delhi High Court that it has drafted a "circular" highlighting the procedure followed by them after a bomb threat call is de-

The submission was made in

On May 22, the HC directed police to file a status report on bomb threats reported to them and had impleaded the Action Committee Unaided Recognised Private Schools, a body which represents schools, before the HC.

On Monday, advocate Arun Panwar, appearing for police, submitted before a single judge

bench of Justice Subramonium Prasad that a status report had been filed. The HC, however, noted that police's report is not on record of the court and asked for it to be done. Advocate Kamal Gupta, appearing for the committee, said he would like to file some suggestions.

"Let suggestions be placed on record before next... hearing... All parties are at idem that this petition is not an adversarial petition but to give constructive suggestions, to have an action plan for if and when there is a bomb scare in schools," Justice Prasad said, listing the matter on September 6.

The police's status report states an action plan has been prepared highlighting steps to be taken by different stakeholders when a bomb threat call is received. The circular, filed with the report, entails legal action pursued by police in case of a hoax call.





मोरे ने दिल्ली के मुख्य सचिव को एक चिट्री लिखकर कहा था कि उन्हें मंत्री भारद्वाज धमका रहे हैं। उन्होंने अपनी चिट्टी में बताया था कि कैसे मंत्री ने उन्हें और कुछ अधिकारियों को बुलाकर बातचीत की। मोरे का आरोप है कि उन्हें गत 16 मई को एक घंटे तक मंत्री ने अपने कमरे में बंधक बनाकर रखा और वह कुछ फाइलों को लेकर उन पर चिल्ला रहे थे।




