



## Govt panel to open channels with Bangladesh, ensure minorities safe

IN THE wake of the turmoil in neighbouring Bangladesh, the Central government on Friday constituted a panel headed by a senior BSF officer to monitor the situation along the border and maintain communication channels with their counterparts there to ensure safety of Indian nationals and minority communities in that country.

In a post on X, Union Home Minister Amit Shah said: "In the wake of the ongoing situation in Bangladesh, the Modi government has constituted a committee to monitor the current situation on the Indo-Bangladesh maintain communication channels with their counterpart authorities in Bangladesh to ensure the safety and security of Indian nationals, Hindus, and other minority communities living there. The committee will be headed by the ADG, Border Security Force, Eastern Command."

Apart from the BSF ADG, the committee will have four other members, said a spokesperson for the Ministry of Home Affairs. They are IG, BSF Frontier HQ South Bengal; IG, BSF Frontier HQ Tripura; Member (Planning & Development), Land Ports Authority of India (LPAI); and Secretary, LPAI.

This came a day after Prime Minister Narendra Modi, while extending greetings to Muhammad Yunus, who took oath as head of the interim government in Bangladesh, expressed hope for early return of normalcy and sought safety of Hindus and other minority communities in that country.

Earlier this week, the BSF addressed multiple incidents of civilian gatherings near the

India-Bangladesh border. "On August 7, Bangladeshi nationals were observed gathering near the International Boundary in two sectors. These gatherings were prompted by fears of attacks by protesters in Bangladesh. BSF personnel, demonstrating exceptional vigilance and proactive measures, responded to these situations, ensuring the security of gathered Bangladeshi nationals,' a BSF spokesperson had said.

According to the spokesperson, in one sector, efforts were made by the BSF, Border Guard Bangladesh (BGB), and local civil authorities to reassure and return the gathered individuals to their homes. "Around 35 civilians returned to their home and the BSF has deployed additional forces to manage the situation effectively. In another sector, a group of villagers of Bangladesh approached the IB, causing a brief commotion. BSF personnel promptly engaged with the group, and the situation was peacefully resolved. The villagers returned to their homes, and BSF forces remain on high alert," the spokesperson said.

#### Parties on Bangladesh turmoil: Cong treads cautiously, BJP & RSS focus on 'threat to Hindus'

AMID THE ongoing turmoil in Bangladesh, where reports of violence, including targeting of minorities, has been reported, various political parties in India have expressed concern, with the statements of some laced with political messaging.

While the Congress has kept its reactions largely general and measured, with a passing mention of minorities, the BJP and the RSS have underlined the threat to "Hindus" and other minorities in Bangladesh. This is in line with the core politics of the BJP and the ideology of the Sangh, where articulating the welfare of Hindus across the world, especially those living in Muslim-dominated countries, is part of core political discourse.



Concerned over violence against Hindus, Buddhists & other minorities: RSS general secy Dattatreya Hosabale

On Friday, RSS general secretary Dattatreya Hosabale issued a statement, asking the Union government to ensure the safety of Hindus and other minorities in Bangladesh. "The RSS expresses serious concern over violence against Hindus, Buddhists and other minority communities in Bangladesh during the movement for regime change in the last

few days... targeted killings, looting, arson, crimes against Hindu and other minority women, and attacks on Hindu temples are intolerable." Hosabale said.

Hosabale said he expects the

Bangladesh interim government to "immediately stop" such incidents, and requested the global community and all political parties in India to stand in solidarity with persecuted communities, including Hindus and Buddhists, at "this critical time". Hosabale's statement comes close on the heels of Modi expressing similar concerns on Thursday. Modi had said: "We hope for an early return to normalcy, ensuring the safety and protection of Hindus and all other minority communities..."

Reports of attacks on minorities and their places of worship in Bangladesh only bolstered the BJP argument that Hindus were not safe in neighbouring Muslimdominated countries. This was the fundamental basis on which the government had passed the Citizenship Amendment Act (CAA) in 2019, sparking protests across the country. The legislation was finally implemented just before the Lok Sabha polls this year.

The reactions from the Congress have been more measured. In his statement congratulating Yunus, Congress president Mallikarjun Kharge had said: "We hope that normalcy and peace returns in Bangladesh, with whom we Indians share a historic relationship. We pray for the safety of all the Bangladeshi people, including all the minorities."

Congress MP Rahul Gandhi's congratulatory message to Yunus only added: "A swift restoration of peace and normalcy is the need of the hour."

STAYS MUMBAI PVT COLLEGE BAN ON HIJAB, CAP AND BADGE

## Shouldn't a girl decide what she wears: SC on college hijab ban

IN STRONG observations that included questions like "should it not be left to a girl to decide what she wants to wear" and how can it be "empowering women by enforcing" a dress code, the Supreme Court Friday stayed a Mumbai private college's ban on the wearing of hijab, cap or badges by students on its campus

Saying it's "unfortunate that you come up with these kinds of instructions after so many years" and "suddenly you realise that there is religion in this country", the bench of Justices Sanjiv Khanna and Sanjay Kumar said: "Issue notice returnable in the week commencing November 18. In the meanwhile, we partly stay clause 2 of the impugned circular to the extent that it directs that no hijab, cap or badge will be worn. We hope and trust this interim order is not misused by anybody. Respondents (college) can move court if it is misused.

Three students of the N G Acharya and DK Marathe College in Chembur, Mumbai, had approached the Supreme Court by filing a Special Leave Petition (SLP) through advocates Hamza Lakdawala and Abiha Zaidi, challenging the June 26 Bombay High Court order that dismissed their plea against the institute's dress code. Clause 2 of the instructions issued by the college stated: "You shall follow the dress code of the

college of formal and decent dress which shall not reveal anyone's religion such as No Burkha, No Nakab, No Hijab, No Cap, No Badge, No Stole etc. Only full or half shirt and normal trousers for boys and any Indian/western nonrevealing dress for girls on the college campus. Changing rooms available for girls."

The students, in the plea, sought direction to quash and set aside the impugned instructions and pending hearing of the SLP, it sought a stay saying if this is not done "their lives and careers will be destroyed". Appearing for the students, Senior Advocate Colin Gonsalves said they had been wearing the hijab to college for four years and there was no problem but "suddenly" the college had come up with the instruction.

The bench questioned the college on the circular. "What is this? They will not reveal their religion... religion is revealed by the name and other things?" Justice Khanna asked Senior Advocate Madhavi Divan who appeared for the college. Divan said, "We are a private,

unaided institution." "Maybe, but don't impose such a rule," Justice Khanna said. The college claimed that the dress code applied to all students, across religious and community lines. It said the obiective behind the rules was to not reveal the religion of students. "You don't want the students' religion to be revealed... Won't their names reveal their religion? Will you ask them to be given numbers at the gate," ustice Kumar asked.

#### Brick kiln owner shot dead in Pratapgarh

Pratapgarh: A brick kiln owner was shot dead by some unidentified attackers, police said on

Superintendent of Police (West), Sanjay Rai, said on the night of August 4-5, Monu Singh (35) was sitting in the veranda of a room at his kiln when unknown assailants approached on foot and shot him before fleeing the scene. Upon hearing the gunfire, locals arrived and informed the police. The severely injured Monu Singh was initially taken to a medical college for treatment, where doctors provided first aid before referring him to SRN Hospital in Prayagraj, he said. He died during treatment today, the officer said. The police registered a case under relevan sections of the law and are searching for perpetrators. PTI



CHINA HAS LODGED a complaint with the World Trade Organisation (WTO) over the European Union's decision to impose anti-subsidy duties on Chinese electric vehicles, escalating a dispute that's straining their already fraught rela-

Beijing brought the case to the WTO's dispute settlement mechanism on Friday, according to a statement from the Ministry of Commerce. The aim is to "safeguard the development rights and interests" of the EV industry, it added.



# भारतीय पुरुष-महिला टीम क्वालीफाई करने में विफल

भारतीय पुरुष ४ गुणा ४०० मीटर रिले टीम शुक्रवार को यहां पेरिस ओलंपिक में उम्मीदों पर खरा नहीं उतर सकी और हीट रेस (शुरुआती रेस) में कुल 10वें स्थान पर रहने के कारण अंतिम राउंड में जगह बनाने से चक गई।

मोहम्मद अनस याहिया, मोहम्मद अजमल, अमोज जैकब और राजेश रमेश की भारतीय चौकडी ने हालांकि सत्र का सर्वश्रेष्ठ तीन मिनट और 0.58 सेकंड का समय निकाला। लेकिन




